GENERAL METHADOLOGY

It has been in part because my health is failing that I have decided that now is the time for me to do this project, but that also means that my health requires that I be able to urgently employ a Koori research person who would :-

- a) assist in the research, collection, archiving and compilation of relevant documents, photographs, films, statistical data and personal tape recordings of relevant persons, etc.
- b) travel on my behalf to visit various people and places in S.E. Australia, that have been part of my life experience, to conduct research and interviews.
- c) conduct a series of tape-recorded interviews with me over an eight month period. Between each session, to transcribe and draft edit transcripts.
- d) to assist in the editing and drafting of the final manuscript.

PRELIMINARY VISIT ITINERARY

A very preliminary list of places that I would expect need at least one visit, would include:-

- SYDNEY Aboriginal Medical, Legal, Housing, Alochol rehab, prisoners services; Trades Hall; Mitchell Library; ATSIC; Dept of Health; Hollows Foundation; the Australia Council; Tranby College; Long Bay and Paramatta Gaols; a host of gymnasiums, pubs, theatres, two-up schools and TAB's, and wharves, to name but a few.
- MELB. Aborigines Advancement League, Vic. Aboriginal Health service, Legal and Child Care services, and numerous other Koori, arts, trade union, prisoner and alochol rehab services and organisations.

CANBERRA- DAA/ATSIC, Institute of Aboriginal Studies, ANU National Art Gallery, Government House, Parliament House (old and new), many embassies and ambassadors numerous politicians and public servants, past and present.

BRISBANE- Aboriginal Health, Legal, Housing, and prsioners organisations, Boggo Road Gaol, and many other people and organisations.

PLUS - Many small towns on the south and north coast of NSW. Numerous incidents and people need to be researched and interviewed to piece together the extraordinary personal experiences and encounters over 60 years that have shaped my present being.

NOTE:

A detailed itinerary will be determined in conjunction with whoever is selected as my Koori research person. Until I know who that is and their availability to conduct this work, I am unable to provide a more detailed proposed itinerary.

CONDUCT OF PROJECT

STAGE 1:

It is anticipated that the most arduous part of the travel and research will be conducted on my behalf by an appropriately qualified and experienced **Koori** research person. Whilst I am considering several possibilities at the moment, (none of whom have been approached) the final choice

is dependant upon their availability and what I might be able to offer. But the most important pre-requisite for the research person is that they be an experienced and politically qualified Koori.

STAGE 2:

Once a significant part of the research material is compiled, taperecorded sessions will begin. I expect that once taping sessions begin, that a first-draft version of a book will emerge from the transcription and each follow-up session.

STAGE 3:

Will be the development from research material and tape transcripts into a draft final version of a manuscript. Again, my research person will play a vital role in assisting me with this stage, but I will not consider the project complete until I have a version of the final draft that I feel is a genuine statement from me.

NOTE:

I propose to conduct the project in the manner described because my present health prevents me from being fully involved in the more arduous aspects of the research, travel and transcription work.

The result of this project will hopefully be that I will be able to ultimately produce a book that will contribute toward a greater mutual understanding between people in Australia, by way of a deeper realisation of the adversity that Koori peoples have had to battle against in this society, and an admiration for the spirit and humour that has helped Aboriginal people stay sane and optimistic through the worst.

If the stories I have to tell about people and struggle don't move readers to a higher understanding, then rest assured, nothing will!
