Writers' Centre and will get them to put a plug in the next newsletter.

I was very sorry to hear of Stephens death while I was away. My sympathies entirely.

My wife and I hope to be able to escape the forthcoming Adelaide Grand Prix - half price tickets will go on sale shortly to allow such an exodus. We are hoping to get over to Melbourne for the weekend and would love to meet for lunch or dinner. I'll phone when I have the tickets in hand and know our movements. We're going to whiz down to Geelong Gaol to see Allan Eric Martin but other than that we'll be reasonably free.

I had the good fortune to get 8 minutes live on Ray Martins Mid-day Show this week - 3 poems and a short but punchy interview. Back in Adelaide an SBS TV team filmed me reading alongside the fence at Yatala, an interview in the barren car park, followed up by a bit of film in my new studio at Carclew. It will be edited and go to air next week on the TONIGHT Show with Paul Murphy. I'd approached John Bannon the night before the interview at a cocktail party he hosted for Artists' Week, asked him for a meeting with himself and the Minister for Correctional Services, and he couldn't escape quick enough. I dropped it into the interview that a senior government official had denied me the opportunity to talk about the prison issue...I'll give him another opportunity and if he doesn't respond I'll give him some embarrasment.
